How the Pro Card Works:

You pay the initial enrollment fee of \$40 before your first demo. You pay \$10 per day to demo up to six (6) skis, wakeboards, or kneeboards. Your Pro Card applies only towards one category. If you wish to demo from more than one category, you must purchase a separate Pro Card for each category. When you are ready to make a purchase, all daily demo fees and the initial enrollment fee are deducted from the purchase price of the equipment. Pro Card purchases may only be applied towards new (no demo, close-out, or swap equipment), current year equipment, and must be made before the expiration date. Pro Card fees are non-refundable, non-transferable, and may be only applied towards the equipment category for which the initial Pro Card was purchased. **Your Pro Card expires _____.** **All Pro Card purchases must be made by this date.**

YOU MAY BE INJURED WHILE PARTICIPATING IN WATER SPORTS

There is a risk of injury by participating in water skiing and/or wakeboarding. The performance of specialized water skis and wakeboards may expose you to injury from impact with the water during a fall, from being hit by the ski or wakeboard, or from not releasing from the bindings during a fall. It is important that you understand that high and low wrap bindings, which are designed to offer more support and control, may not allow your foot to release in all situations and may increase the risk of serious injury.

In order to minimize your risk of injury, you should always:

1. Use only the correct size ski/wakeboard and binding(s)
2. Wet the binding(s) and your foot before use
3. Wear a US Coast Guard approved flotation device
4. Wear a water ski helmet
5. USE COMMON SENSE!!!

WaterSports Equipment Rental / Demo Policy

- ◇ Fee is \$10 per day on the Pro Card program, or \$15 per day for rentals.
- ◇ Equipment must be picked up after 3:00 p.m. and returned before 1:00 p. m. on the date it is due back or you will be charged an additional day.
- ◇ You must certify that the equipment you are borrowing is within your skiing or riding ability.
- ◇ 100% damage deposit is required on all rentals or demos before the equipment is checked out.
- ◇ All equipment must be returned in the same condition as it left. If it is scratched, dented , broken, or otherwise damaged, you will be charged accordingly. These charges will be deducted from the damage deposit.
- ◇ Ski handle dents and scratches on the top or bottom of the ski or wakeboard are considered damaged and not normal wear and tear.
- ◇ Pro Card fees will only apply towards purchase if equipment is returned in the same condition as it left.
- ◇ 100% of your deposit will be returned ONLY if the equipment is returned undamaged.
- ◇ Each customer is allowed no more than one ski or wakeboard per day.
- ◇ PLEASE keep the ski or wakeboard inside its cover when not in use.
- ◇ A \$5.00 cleaning fee will be charged for any equipment that is dirty.
- ◇ Fees are paid in advance and are not returned or refunded if you were unable to use the equipment for *any* reason.
